

# ALBAYEN SCHOOLS USER TERMS OF SERVICE

#### 1. INTRODUCTION

Welcome to Albayen® Learning and Teaching Support System. Albayen Schools is a digital platform that provides teachers the comprehensive teaching management tools to share learning materials with their students and monitor the students' progress (the 'Platform'). The platform and its related services, products, software programs, and content are collectively referred to herein as the 'Services'.
